This application is the first part of the registration process. A non-refundable deposit of \$200 (made payable to Temple Israel) must be submitted with this application. Registration fees are due by Friday, December 23, 2022.

In May, you will receive your family's tuition packet that clearly states your financial responsibility for the 2023-2024 School Year. At that time, your deposit will be due. If your child is at JGELC for the Core Day only (9:00 am – 1:00 pm) the deposit is \$750.00. If your child is enrolled in any of our Extended Care Options (Early Care, Extended Day or After Care) the deposit is \$1500.00. All deposits must be paid by June 1, 2023. The deposit is applied to your final bill. Your first payment will be due September 1, 2023.
